

Please see below, a response from the Head of Legal Development at WIPO, Mr Christian Wichard, pertaining to the abovementioned extensions and the UDRP's applicability to these extensions:-

In the "Terms and Conditions" of CentralNic, the company offering this kind of registrations, Clause 14 states: "CentralNic may at its sole option, cancel the registration or suspend registration of the domain name if a. ordered to do so by a court of competent jurisdiction; b. following the ICANN Uniform-Domain-Name-Dispute-Resolution-Policy the name has been judged to infringe the trademark or other intellectual property of the complainant; c. the use of the domain name is illegal; d. if there is a breach of these terms and conditions; including without limitation, clause 1; e. the continued use of a domain name could cause technical problems on the Internet."

In two recent decisions, WIPO Panelists have found that the UDRP does not apply to domain names registered under these (or similar) terms and conditions.

The decision, rendered in case No. D2001-1484 (http://arbiter.wipo.int/domains/decisions/html/2001/d2001-1484.html), concerned a third level domain name registered in ".uk.com". In that decision, the Panelist found as follows:

"The Panel questions whether the new/current CentralNic terms and conditions properly and effectively incorporate the Policy. There appears to be no express incorporation of the Policy...The Panel has not been shown the terms of the agreement(s) between CentralNic and ICANN and/or the registrar for the '.uk.com' domain names, but it may be that the only entity properly subject to the Policy in respect of the '.uk.com' domain names is CentralNic itself."

The Panel therefore found that it had no jurisdiction to hear the Complaint insofar as the "uk.com" domain names were concerned. The panel emphasized,

however, that it did "not seek to circumscribe how a future panel might approach the issue."

In case No D2002-0895
(http://arbiter.wipo.int/domains/decisions/html/2002/d2002-0895.html),
i9nvolving a ".eu.com" domain name, the Panel held

"There is, however, nowhere in the Terms and Conditions..:any explicit reference to the Policy nor to any obligation to submit to a mandatory administrative proceeding; on the contrary, the reference to the exclusive jurisdiction of the English courts seems to point to the contrary. Furthermore, the wording of the clause...seems to mean that the Registrar has the option to follow a decision or not, and in any case there is no mention of any possibility to transfer a domain name to a complainant, and, further, reference is made only to "infringement" of a trademark and not to the type of finding that Paragraph 4 of the Policy is concerned with... This lack of legal clarity about the applicability of the Policy and about the resulting obligation for Respondent to submit to a mandatory administrative proceeding is a particularly serious matter in the context of the simplified written administrative procedure under the Policy, which, in the view of the Panel, must ha! ! ve a clear legal basis... In view of those considerations the Panel must - regrettably and reluctantly - come to the conclusion that it has not been established that the Policy applies to the domain name at issue and that, consequently, it has not been established that the Panel is competent to consider the case. The Panel therefore has no choice but to dismiss the Complaint."

Since CentralNic does not seem to have revised its terms and conditions, the above considerations would still seem to apply. Even though future panels would not be bound by the above considerations, they are likely to follow them as a precendent in similar cases.

I suggest that you contact CentralNic (http://www.centralnic.com/), itself regarding the application of any dispute resolution mechanism referred nto in their 'Terms and Condistions".

It seems to me ill advised to make policy based on a single case. To the extent that this may represent some kind of trend, then it should perhaps be noted in passing as a development which bears further observation.

Furthermore, even if a problem exists, and it is sufficiently widespread to warrant a change in a policy of general applicability, then the costs of any solution must be equally considered. The initial work of this TF in analyzing successes and problems of application of the UDRP to second level domains will provide necessary information for even the consideration of issues in the third level domains.

Finally, I observe that this is an area that potentially implicates policy areas staked out by the GAC and sovereign governments on the use of two and three letter country codes in gTLDs. While UK is not, I believe, an official country code on the ISO 3166-1 list, the controversies surrounding this particular area of naming appear to me a dangerous diversion for the TF.

As an aside, I'm not sure whether a significant problem could exist in this circumstance. The theory of cybersquatting is based on consumer confusion — the cybersquatter misdirects the user with an identical or confusingly similar name. The .uk commercial second level is ".co". I can understand a consumer potentially typing "name.uk.co" instead of "name.co.uk" But to invert the ccTLD and add the .com extension? This seems to me very unlikely to occur — even to the novice internet user.

I presume that even browsers (if there are any) that still automatically append ".com" to entries without a TLD do not do so if there is a valid TLD extension (".uk").

Acceptable Use Policy Version 1.9 Introduction

This Acceptable Use Policy encourages the responsible use of Network Solutions' services and delineates the relatively narrow range of uses of Network Solutions services that are contrary to Network Solutions' mission, generally because such uses either pose an unacceptable risk to the stability, integrity, or quality of Network Solutions' systems or the systems of its vendors, or harm (or threaten to harm) the rights and interests of third parties. #### Prohibited Uses

You may not transmit, distribute, or store material that contains a virus, "Trojan Horse," adware or spyware, malware, corrupted data, or any software or information to promote or utilize software or any of Network Solutions services to deliver unsolicited e-mail. You further agree not to transmit any material that encourages conduct that could constitute a criminal offense, gives rise to civil liability or otherwise violates any applicable local, state, national or international law or regulation.
  - 2. Sending Unsolicited Bulk Email ("UBE", "spam"). The sending of any form of Unsolicited Bulk Email through Network Solutions' servers is prohibited. # Online Copyright Infringement Liability Limitation Act

## **Knowledge of Infringing Material**

To qualify for the § 512(c) safe harbor, the OSP must not have actual knowledge that it is hosting infringing material or be aware of facts or circumstances from which infringing activity is apparent. It is clear from the statute and legislative history that an OSP has no duty to monitor its service or affirmatively seek infringing material on its system. [12] However, the statute describes two ways in which an OSP can be put on notice of infringing material on its system: 1) notice from the copyright owner, and 2) the existence of "red flags."

This is advantageous for OSPs because OCILLA's clear process allows them to avoid making decisions about whether or not material is actually infringing. Such decisions can be complex both because it is difficult to determine whether the copyright has expired on a material without access to complete information such as publication date, and because even copyrighted material can be used in some cases under the doctrine of <u>fair use</u>, the applicability of which is difficult to evaluate.

Instead of making a complex legal determination, OCILLA allows OSPs to avoid liability provided they comply with the terms of the statute, regardless of the validity of any claim of infringement.

#### **Red Flags**

The second way that an OSP can be put on notice that its system contains infringing material, for purposes of section 512(c), is referred to the "red flag" test.[12] The "red flag" test stems from the language in the statute that requires that an OSP not be "aware of facts or circumstances from which infringing activity is apparent."[18]

The "red flag" test contains both a subjective and an objective element. Objectively, the OSP must have knowledge that the material resides on its system. Subjectively, the "infringing activity would have been apparent to a reasonable person operating under the same or similar circumstances."[12]

## Notice from Copyright Owner

The first way an OSP can be put on notice is through the copyright holder's written notification of claimed infringement to the OSP's designated agent. This must[13] include the following:

- (i) A physical or electronic signature of a person authorized to act on behalf of the owner of an exclusive right that is allegedly infringed.
- (ii) Identification of the copyrighted work claimed to have been infringed, or, if multiple copyrighted works at a single online site are covered by a single notification, a representative list of such works at that site.
- (iii) Identification of the material that is claimed to be infringing or to be the subject of infringing activity and that is to be removed or access to which is to be disabled, and information reasonably sufficient to permit the service provider to locate the material.
- (iv) Information reasonably sufficient to permit the service provider to contact the complaining party, such as an address, telephone number, and, if available, an electronic mail address at which the complaining party may be contacted.

>>> CentralNic have a manipulated "Whois" document, with their Whois code, immediatly above that of the party they are Contributory Infringers for.

- (v) A statement that the complaining party has a good faith belief that use of the material in the manner complained of is not authorized by the copyright owner, its agent, or the law.
- (vi) A statement that the information in the notification is accurate, and under penalty of perjury, that the complaining party is authorized to act on behalf of the owner of an exclusive right that is allegedly infringed.



It must be noted that, the requirements of the end user, of services sold by CentralNic [I eriSign & Network Solutions] are as follows: "mbject to oversight by third parties, [I eriSign & Network Solutions], without limitation, the rules, regulations and policies of the Internet Corporation of Assigned Names and Number ("ICANN") the U.S. Department of Commerce, the registry administrators of a registry administrators of an experimental agreements between CentralNic and such registry administrators and other technical service providers [I eriSign & Network Solutions], on the Party Obligations").

CentralNic acts as registry for <u>uk.com</u>. We do this independently. (Proven a lie. At the pleasure of VeriSign, who own an integral part of Network Solutions, who CentralNic is in a public relationship with.) We are the registrant of <u>uk.com</u> and we sell our sub-domains such as <u>landquise.uk.com</u>

Selling to unauthorized firm(s) accommodates "dilution" and in CentralNic's published mission statement, your in essence, turning a "blind eye" on the fact that entities who secure cc.TLD domains, such as "Landonise uk.com" are not sanctioned or authorized to "create" ... a simultaneously local and global Internet Identity.

Nominet is the registry for .uk (<u>co.uk, org.uk</u>, etc). We are distinctly different companies that manage distinctly different domain endings and operate under our own policies when it comes to trademark law. Although Nominet have been very kind to reply to you and answer your questions, I'm sure they will acknowledge that they have nothing to do with domain names that end in uk com.

There is a close knit relationship!

Related to ICANN, As an independent registry CentralNic does not have a formal agreement with ICANN and we are not required to. (This is left to VeriSign.) This is because we offer our <u>sub-domains</u> independently. Our sub-domains (like <u>landoruise uk com</u>) are short and easy-to-remember so many registrars offer them as an alternative when a .com or a .co. uk domain is desired but unavailable.

## Who are CentralNic?

CentralNic was founded in 1995 with the vision of bringing more choice and competition into the domain name marketplace. When Nominet launched the .CO.UK domain for the UK in that year, the original price was to be about £150.

However, once Nomination (CentralNic's predecessor) launched the <u>UK.COM</u> registry, inspired by an idea suggested by Internet "founding father" <u>Jon Postel</u>, charging only £32.50 per year, the effect of the additional competition reduced the price of domain name registrations in the UK, to the point where the UK is now one of the biggest marketplaces for domain names in the world, disproportionate to its population.

#### Growth

CentralNic brings experience, expertise, and a competitive business style to the domain registry space...

As the UK COM registry grew, it was recognised that there was further potential to introduce new second-level domain names to compete with ccTLDs that had excessive pricing and restrictive registration rules. As a result, in the year 2000 Nomination was reformed into **CentralNic**, with a large portfolio of two-letter .COM and .NET domain names, covering over 70% of the world's population.

From the beginning, CentralNic's business model was well suited to offering a scalable registry platform: multiple namespaces were offered side-by-side (whereas most registry systems could only handle a single namespace and had to be cloned in order to support more than one TLD), and a strong emphasis on registrar-led sales and marketing which was an innovation in the days before the Shared Registry System (SRS) was introduced, when (the original) Network Solutions (now VeriSign) had a monopoly on all gTLD registrations.

That domain is registered with Network Solutions as a Customer not as a Licensee of Network Solutions.

Based on your voice message, I am providing the following information:

Network Solutions is accredited by ICANN as a Registrar and is not in control over ICANN. As for your inquiries regarding Central Nic and their accreditation history, I am sorry, but I will have to refer you to Central Nic for any information regarding their organization.

As we discussed earlier, Registrars are not responsible for determining the rights of domain name Registrants. Therefore, we are not in a position to prohibit the registration of domain names that may infringe on the trademark rights of an individual or an organization. If you have the domain name trademarked, you do have legal recourse and I urge you to consult an attorney to secure your rights under the law. I hope that helps.

## Geographical Domain Names. -WIPO 2000 Process

owing our discussion at your Brussels meeting I am writing about the applicability of the WIPO UDRP to registrants of CentralNic ains.

Before addressing this issue however I would like to provide you with some history and facts that I hope will help to explain the position of Centra1Nic in the Domain Name field. As a Registry we "fall between the cracks" of ccTLD and GTLD registries and outside the normal jurisdiction of ICANN. I also recognise that there are a number of private registries whose behaviour and business practices are not up to a good standard.

CentralNic has always attempted to uphold good practices in the Registry business. Many major companies will attest to you our support and helpfulness in disputes relating to trademark infringement and cybersquatting. Our record of never having been sued in over six years of operating as a registry attests to this.

Your report lists potential areas of abuse that could arise from our position, and to be fair it also makes the point that such abuse is not taking place. It does not however highlight the benefits that can arise from us providing choice in many countries.

In the UK we started trading six months before Nominet UK. At that time it was proposed that domains under co.uk would cost £200 UK (approximately 320 Euros) each. I believed this to be an abuse of monopoly power and I consulted the late Jon Postel. It was he who suggested that I should set up uk.com as an alternative registry. I did so, pricing uk.com at £65 UK. When Nominet UK started trading, co.uk was priced at £100 UK and quickly dropped to £80 UK. This story illustrates that competition can be good and beneficial to users and registrants.

There are also many countries, even in Europe where ccTLD managers (who are not always Government controlled) apply restrictive and capricious controls and exorbitant pricing to domain names. The provision of a good alternative choice backed by a company such as Centra1Nic, which has a good reputation and an enviably long trading record in the Internet arena, is a useful service to Internet users.

I would welcome some recognition of the good we can bring as well as the largely theoretical potential abuses that are mentioned in your report.

primary reason for this letter relates to the UDRP and its applicability to CentralNic's registrants. In your report you have made the following recommendation:

"1. With regard to the use of the ISO 3166 code elements in the currently existing gTLDs, we do not express any opinion on the question of whether use should be forbidden retroactively. However, the persons or entities who have registered these codes and accept registrations of names under them should be encouraged to take measures to render the UDRP applicable to these registrations to ensure the proper and prompt implementation of decisions transferring or canceling the registrations resultingfrom the UDRP."

As the chairman of CentralNic I would like to confirm to you our agreement in principle to the adoption of your UDRP. There are a number of issues that we would like to discuss:

The first is one that I believe my colleagues at Nominet UK (of which I am also a director) have also brought up with WIPO. Both Nominet UK and CentralNic have traditionally used informal mediation in the dispute arena. To date this has resolved around 80% of cases, saving all concerned considerable legal costs and enhancing our reputations. The UDRP provides no opportunity for such informal mediation. I would wish to offer this possibility as a phase that disputants can choose to go through prior to entering the UDRP. I hope that ultimately WIPO will adopt this as an integral part of your DRP.

The second is the question of retrospective application. We can re-word our terms and conditions to bind future registrants to a DRP but I am doubtful about, and indeed uncomfortable with applying such a major change retrospectively. I would prefer to offer the UDRP to all our current registrants and change their contracts to make it mandatory on renewal - a two-yearly process at present.

The third is more in the way of a proposal. As you may know CentralNic has a strong interest in the legal issues surrounding the ownership of Domain Names. Cathy Horton, our Legal Director gave a presentation at RIPE 38 of a legal platform for giving registrants a stronger and more reliable grasp and control over their domain names. One of the problems faced by the intellectual property community is that they may hold a trademark or brand name in multiple jurisdictions and are forced to fight cybersquatting cases in several jurisdictions (cybersquatting is much more effective if the perpetrator holds a "set" of domains - com, net, org, co.uk, uk.com, and so on).

It is our view that UDRP would be very much more effective if it could apply to all gTLD's and ccTLD's and private registries. We would strongly support the development of such a universal procedure that gathered together the "best" of the various dispute resolution systems. This is an activity which WIPO and CENTR could jointly undertake. The acceptance of such a universal policy could be written into the long-awaited ICANN-ccTLD contracts.

I would be happy to discuss these matters with you in the spirit of wishing to place Centra1Nic in harmony with WIPO's excellent imprive to regulate a somewhat turbulent area.
